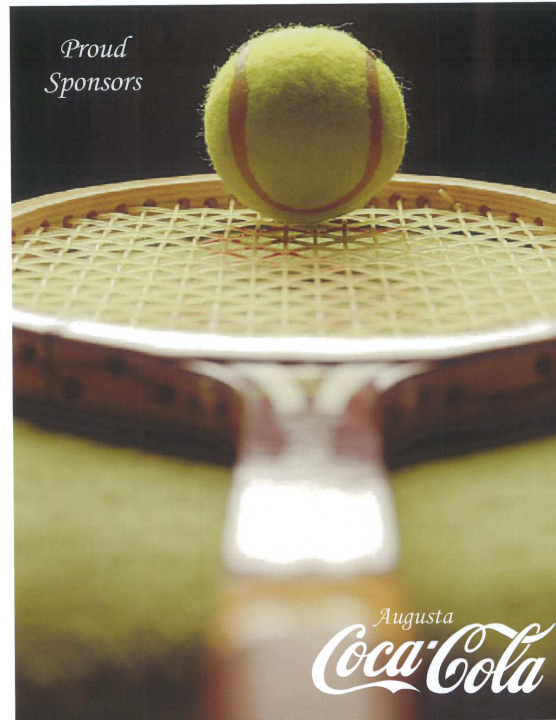

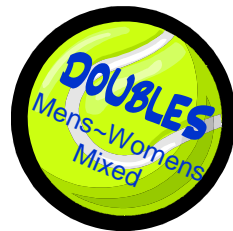

Schedule: The schedule of matches will be determined based on the number of registered participants. Double elimination rounds will be played since there is no known ranking of the players. Each player/team of players will play at least two matches during the tournament. **Finals schedule is on the next page.**

Sets: The number of sets in each match will be determined by the number of registered participants and time available for play. For the finals, men (including singles and doubles) will play best 2/3. Women's finals (including singles and doubles) will play best 2/3. Mixed doubles will play best 2/3.

NOTE: Awards will be given to winners and runners up immediately following each match. In case of rain, finals will be postponed until the following Saturday following the schedule as above, including the parade. Should matches take longer than the allotted two hours each, subsequent matches will be played immediately following the previous match.

Rules & Regulations: All players should provide their own rackets. Balls will be provided by the tournament organizers and/or sponsors. The chair umpire has the final ruling in all matches. We do not have the liberty of monitors to confirm or deny a call. Violent outbursts, hitting balls into the crowd, throwing rackets, cursing or verbal abuses will not be tolerated. Players will be disqualified immediately for such behavior. With the same respect, taunting and overzealous reactions to winning a point will not be tolerated. Please, refrain from celebration until the match is over and conduct yourself in a respectful manner. Players will be expected to shake hands with opponents at the end of each match. Chairs, towels, water and Powerade will be provided for players. At least one ball chaser will be provided by the tournament organizers for each match.
